ENTRY FORMALITIES - VISA AND IMMIGRATION REQUIREMENTS



All participants must have a passport with a minimum validity of six (6) months

Visa: Citizens holding passports from ECOWAS, the EU, and the US do not require a visa to enter Cabo Verde.

Airport Taxes: At least 5 days before departure to Cabo Verde, all participants, regardless of nationality, must register on this government platform - **EASE**: www.ease.gov.cv. An airport tax of 31 Euros will be charged, which can be paid online or upon arrival in Cabo Verde.

Vaccination: The yellow fever vaccine must be valid on the International Certificate of Vaccination or Prophylaxis (ICVP), issued by the WHO, if arriving on flights from Senegal or other West African countries.

The following airlines offer direct flights to the islands of Sal and Santiago, departing from **Lisbon, Dakar, Lomé, Casablanca** and **Ponta Delgada**.



RECEPTION AND TRANSPORTATION AT THE AIRPORT
